Thrive and its Collaboration achieved significant results during the 2018 fiscal year. The teen birth rate, our overall measure of success, declined 29 percent in just three short years (from 2013, the baseline year for data in our Comprehensive Plan to Reduce Teen Pregnancy, to 2016, the latest available data). We know our Collaboration's coordinated, comprehensive strategy is working, and we are poised to take our efforts to the next level to ensure we can sustain this decline into the future.

Beyond the overall teen birth rate, the Collaboration achieved a number of accomplishments in each of the three pillars from our Comprehensive Plan:
