

**Thrive: Sexual Health Collective for Youth leads a public-private collaboration with a common agenda of reducing teen pregnancy in Central Oklahoma. The collaboration is comprised of more than 40 organizations and 260 individuals committed to this common agenda and to the collective impact model.**

**In 2018, the collaborations 4-year goal - to reduce the teen birth rate in Oklahoma County by 1/3 by 2020 - was met. The teen birth rate in Oklahoma County has shown a reduction of 42% between 2012-2018, since the collective impact approach was adopted to address this sytemic issue.**

**To ensure we build upon this momentum, we implemented a 12-month strategic planning process, which resulted in a new 5-year comprehensive plan with a bold goal of 25% further reduction in the teen birth rate by 2025.**

**The comprehensive plan was developed through a culmination of efforts including: a detailed data review of local and national data pertaining to reproductive health with our community as a whole as well as key at-risk populations; state and local policy review; interviews with key community leaders and stakeholders; and listening sessions with youth and partner collaboration and feedback throughout the development process.**

**Thrive conducted a broader community engagement assessment for Oklahoma County as well. This gave the collaboration important baseline community data that spoke to the readiness of the community in regards to reproductive health in a variety of settings as well as barriers faced and resources needed for adults to engage adolescents in meaningful reproductive health conversations.**

**In addition, we completed the first year of a two-year federal grant titled Innovative Strategies (Tier 2) to Prevent Teen Pregnancy and Promote Healthy Adolescence. Through this grant, we are evaluating the effectiveness of collective impact as an innovative and uniquely effective strategy for teen pregnancy prevention. This first year has resulted in the creation of a systems map that provides an understanding of the current teen pregnancy landscape in Oklahoma County at an individual, interpersonal, organizational and community level. The project has also yielded valuable data from our partner organizations about the effectiveness of our collaboration.**
