Honestly's Mission: We are building a movement to improve sexual health outcomes for youth. Through coordinated action and strategic alignment of our Collaboration partners, we facilitate systemic change to create sustainable improvements in youth sexual health outcomes. Our work focuses on advancing evidence-based, comprehensive, medically accurate, and age-appropriate education and resources while addressing systemic barriers and promoting health equity.

Honestly serves as the backbone of a community wide collaboration. In FY24, Honestly strengthened its collaborative foundation through intentional relationship-building and strategic planning. A key milestone was the audit and expansion of our partner contact list from 206 to 314 engaged members-broadening the base of those contributing to our mission. Honestly launched a new Advisory Council made up of diverse individuals priority populations for teen pregnancy prevention efforts. This council plays a vital role in guiding the direction of the Central Oklahoma Teen Pregnancy Prevention Collaboration and ensuring community-informed strategies. Throughout the year, Collaboration-Wide meetings had 85 attendees, contributing to shared learning and collective impact. Honestly launched its first Reproductive Well-Being Learning Cohort, serving 10 individuals from 8 organizations across our community. The program offered an in-depth educational experience centered around the reproductive well-being framework and collective impact, empowering participants to lead change in their communities. The cohort attended 4 educational trainings and 4 project design sessions. The cohort concluded with a community-facing art show, amplifying the voices and creativity of the community. Together, cohort members reached over 500 community members through their efforts. Through

the expansion of Project Equip, Honestly deepened engagement with professionals and caregivers supporting youth across Oklahoma. Through Braving "the Talk," a curriculum developed to support at risk youth in Oklahoma, Honestly staff attended the Child Abuse and Neglect Conference, connecting with 207 individuals and distributed over 200 youth sexual health resources, helping equip providers with tools for informed, supportive care. Project Equip supported 12 targeted trainings, reaching 174 attendees, and received strong feedback indicating an overall rating of above average or excellent. In partnership with Amplify, Honestly hosted the Sex Ed Kickoff, a 1-day conference for sex educators from across the state, with 57 attendees joining to share strategies, resources, and momentum. In addition, Honestly successfully developed the next five-year strategic plan, Forward Together, a roadmap to guide collective efforts around youth sexual health and well-being in Oklahoma County. Our planning process engaged: 58 stakeholders through a Collaboration-wide survey, 7 targeted group listening sessions, and hosted 10 in-depth interviews with key stakeholders. These conversations shaped a plan that is responsive, inclusive, and rooted in community insights. Forward Together will launch in 2025. This fiscal year reflects Honestly's continued evolution into a trusted, community-centered leader in youth sexual health and caregiver support. Through collaborative planning, strengthened partnerships, and dynamic training opportunities, we laid a strong foundation for even greater impact in the years ahead.
